Unto the populace,

I am writing to extend to you some of the plans that I would like to implement during my reign as prince of the Celestial Kingdom. I know that e-mail is at best a peripheral method of communicating information to the populace, but hopefully this information will reach the populace through park members with internet access.

1st. I am very much looking forward to increasing the awareness of arts and sciences happenings in the kingdom, and holding and promoting A&S tournaments. I strongly urge anyone who can make it to attend collegium at Colonsfield on May 27. There is a very strong cast of experienced teachers (I'm one!!) and the site has excellent facilities (the Facil & Long Room, Main Street, Bostrop). I will provide more information as I get it. The kingdom shall also sponsor one A&S tournament per month. Preferably, I would like to hold these tournaments in different principalities per month. These tournaments will be held in conjunction with a local event (so park leaders, please submit to me the dates for your midreign and quads). I have been authorized to award prizes to the winners of these tournaments. Said prizes will be in the form of gift certificates to supply stores (leather factory, Hancock fabrics, Home Depot, etc).

2nd. I am still adamant about having every park submit a symbol or coat of arms for their lands. I have visited several parks in the last three weeks, and some parks say they have a symbol, but have not published it and do not have a drawing for me to look at. I have a small force of tailors assembled to start working on local park banners. We will of course begin with those lands that already have symbols. Please submit your park symbols by midreign.

3rd. What about that webpage. I think Terrellian has done his best with the webpage, but the problem we have is that we need a dedicated webpage server and some way the RCM can update the page frequently. I have already started making inquiries into private firms to take over the design. Yes, it will cost money, but it is a necessary evil, and the populace will not be taxed any further to afford this. We could have someone in the CR design and program the webpage, but that's like lending money to a friend... I would much rather have accountability than wishful thinking.

4th. I hope to make the Obor a regular publication. Under the corpora, the RCM is tasked with publishing the Obor. I have met with Sir Father Tom and we agreed to work on the Obor jointly to insure it's publication. These issues will be mailed to either the park leaders or to the park contact, depending on who has a reliable mailing address.

Letter from the Prime Minister

With this in mind, the Kingdom will be celebrating ten years of the Dream at the Mid-Reign Celebration of Our Queen, HRM Countess Dame Mistress Wynd o'OnyxLoch. Also at this Mid-Reign, I shall be stepping down as Your Prime Minister and handing over the proverbial reigns to whomsoever is chosen by the People that Saturday night of Mid-Reign Feast. Hopefully that person who takes this responsibility will understand the job that they will be assuming, and all that it entails. Good Luck!

Looking back on the four months that I have been in office I see that this Kingdom, and Amtgard as a whole is not all fun and games at times. While living in Our collective Dream, we have realized that our lives and interaction within the confines of the Game at times can mirror things that happen in Mundane life. What I mean by this is that although we play this game in a fantasy setting, we must remember that feelings can still be hurt, anger can erupt spontaneously, fights can still happen, and laws can still be broken. For real. However, we must also remember that we as a club, and we as a group of friends fighting and playing together can often handle most of these problems like friends should. By talking about it and deciding what the best course of action for ALL individuals should be. If things cannot be settled easily between people, then it should be brought before the leadership and management of the Club. Another thing to consider is how to "bring it up". Is it a "game" issue? Is it a "mundane" issue? These are questions that can usually be answered by those among us that have the knowledge, experience, or training to give substantiated answers. Look to your Reeves. Look to your park leadership. Look to your Knights. These should always be your first step in solving problems. Usually the problems turn out not to be as severe as first thought.

Looking forward to my remaining time as Our Prime Minister, I hope to be able to initiate some ideas that hopefully my successor will continue to see through. One of these ideas is a restructuring of how we pay our "donations" to the Club. I'm talking about dues, folks. Historically we have paid our dues to our local Park Leaders, and they in turn forward a percentage to the Kingdom. Well, we all know how well that works. What I hope to change is how, and to whom the populace pays it's dues. I am forwarding a proposal to be voted upon during the next Kingdom Allthing to change the monthly dues to yearly dues. These dues will be paid either by mail to the Prime Minister, or in the case where this just cannot be achieved for some reason or the other, directly to the Prime Minister at Major Kingdom Event. The amount of these dues will be the same as always, only for one year at a time. It will be \$12 for twelve months. New members will receive back in the mail a copy of the Amtgard Rules of Play, a copy of the Celestial Kingdom Corpora, and a copy of the Dor Un Avathar (Monster Manual). They will also receive a Membership Card stating their Amtgard as well as Mundane name, and the expiration date of their membership. Members renewing their dues will receive copies of their records, and a membership card. The method for mailing these dues in will be made easier by the use of combined membership/waiver forms that will be provided along with self addressed stamped envelopes. In time, we hope to get formally printed postage paid envelopes. If anyone has ANY questions about this method, please contact me, the sponsor of this Allthing Proposal.

The next part of this letter has to do with Your records, and how they are being provided, or most times NOT being provided to the Kingdom. Currently the system in place is that all park leaders should be forwarding copies of their provincial records to the Kingdom, monthly. This allows the kingdom to keep up to date on individuals credits, awards, new waivers signed, etc. on a timely basis. If we the Kingdom management do not receive your records from your park leaders, we cannot satisfactorily keep the information accurate. There are very few instances of the Kingdom receiving these monthly records. I applaud those groups that have been diligent in this effort, however, I must also remind those groups that have been falling down on the job, that their respective populaces may be quite disappointed come the day that they see what the Kingdom actually has on them. A hint to anybody in this game is to keep copies of all your own records, always keep your awards in a safe place, and keep a good rapport with your park leadership. It gonna suck when you realize that all those credits you've been pumping into your respective class for the past year don't exist.

Well, I do believe that I have rambled long enough here. Just remember, we ALL play this game, and we ALL are responsible for not just ourselves but each other as well. Take care of your own backyards of course, but don't forget that your neighbors may need some help from time to time as well.

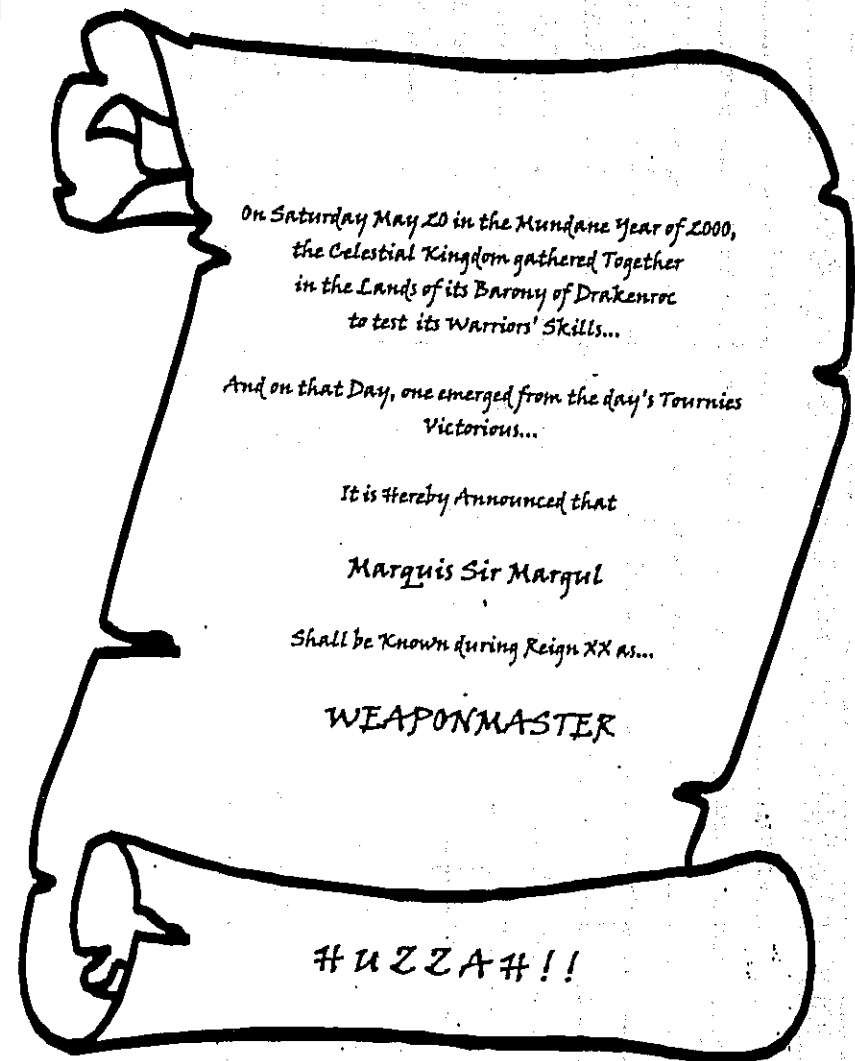
